

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the SCANTRON CORPORATION HEALTH & WELFARE BENEFITS PLAN, EIN 95-2767912, Plan No. 505, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

SCANTRON CORPORATION has committed itself to pay certain self-insured Medical, Dental, Short-term Disability, and Employee Assistance Program claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with VISION SERVICE PLAN, DELAWARE AMERICAN LIFE INSURANCE COMPANY, UNUM LIFE INSURANCE COMPANY OF AMERICA, and UNUM INSURANCE COMPANY to pay Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Business Travel Accident, Critical Illness, Hospital, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$389,448.
